Soon after I started seeing the same behaviors as I did watching Mr. Lewis as Police Chief. Here we are now and I see his way of managing is just as toxic as it was while he was PC.

I have never seen a CM be so incredibly disrespectful to the general public treating this City as his kingdom and he is king. I have seen the very definition of a Workplace Bullying from Mr. Lewis. He has a tendency to lash back, retaliate, intimidate, be insubordinate to and at anyone who dares to cross him, going as short as threatening me with the nefarious "you're next, wink and gun" as late as last Council Meeting. I have called for his resignation, his termination and spent my days placing fliers DT with my own personal #TimeTOTossyTy805. I have seen him verbally, physically attack and send his closest significant others to intimidate some of us into silence. Maybe Mr. Lewis does not understand that the majority of this city is afraid of him. I am not, and after a year plus of inappropriate Workplace Violence I urge the council to terminate Mr. Lewis immediately, and if you are not willing to do so. Place him on Administrative Leave until the remainder of his contract is over. Mr. Lewis like many in the Biden administration is the very definition of the Peter Principle. Our city and our constituents deserve much better. We will be paying his pension for years to come at high rates of compensation. I urge you to relieve Roblans of Mr. Lewis and let the women feel safe again.
